Rules of Court 2021 In exercise of the powers conferred by section 80 of the Supreme Court of Judicature Act and all other powers enabling us under any written law, we, the Rules Committee, make the following Rules

Supreme Court of Judicature Act 1969 An Act to provide for the jurisdiction and powers of the superior courts of judicature

State Courts Act 1970 An Act relating to the constitution, jurisdiction and powers of the State Courts and the administration of justice therein
